#### **TOURNAMENT RULES**

1. This tournament is certified by the USBC and shall abide by all tournament rules of the USBC. Current USBC membership or proof of membership must be presented at the check-in desk for all entrants.

2. All female adult members of the First Coast USBC association are eligible to enter. Non-members living within the jurisdiction of the association may enter by paying the membership fee of \$25.00.

3. Cash prizes shall be awarded on a handicap basis with one spot for every 8 entries. Prize money will be returned 100%. In case of ties for 1st Place, Co-champions will be declared and cash prizes for affected positions shall be combined and evenly divided.

4. No entry shall be refunded after the schedule has been accepted and posted. Acts of God and situations beyond the control of the tournament committee excepted.

5. Tardy bowlers will start in the frame being bowled with a zero (0) given for each frame missed. Pacers will not be permitted.

6. Protests concerning eligibility or general playing rules shall be made in writing to the tournament director or an Association officer within 24 hours after completion of that squad.

7. USBC Rule 319A, B, and C is in effect for this tournament (this includes the 10 pin rule).
Misrepresentation will result in disqualification. Bowlers with no certified average will bowl scratch.
8. The tournament director reserves the right to re-rate any bowlers average.

9. Extremely boisterous and disruptive behavior shall provide the basis for disqualification of an individual from continued participation in the tournament and removal from the bowling center.

10. **DRESS CODE:** No short shorts or skirts above mid-thigh. No sleeveless shirts. No midriff shirts. Proper attire addressed by the house director.

11. Re-entries will be allowed if available but bowler may cash only once in Singles event or with a different partner in Doubles.

## EVENT INSTRUCTIONS AND RULES

Bowlers shall check in at least 30 minutes prior to scheduled bowling time. \*SQUADS WILL START ON TIME. WARM UP WILL START 10 MINUTES BEFORE SQUAD TIME\*

## AVERAGE RULES

1. Average on which to base handicap shall be the highest 2023-2024 FCUSBC yearbook. If not in the yearbook, a bowler's current season highest average in the FCUSBC, minimum 21 games as of January 1, 2025 may be used. A bowler with none of the above may use the highest 2024 summer league average, minimum 21 games, providing such average is on file at the Association office. HANDICAP will be 100% of 230.

2. Those who do not have any of the above averages must bowl scratch.
